He also led numerous financing or refinancing deals totaling upwards of \$180 million dollars. Prior to Retrocom Mid-Market REIT, he was President and Chief Executive Officer at Telepanel Systems Inc., a publicly traded high-tech company, Vice President, Finance and Treasury at Lehndorff, Chief Financial Officer at Camreal Management Inc., and Audit Manager at KPMG.

David Fiume acquired his Chartered Accountant Designation from the Institute of Chartered Accountants of Ontario and completed his Bachelor of Commerce from the University of Toronto.
