2. Update on Auditor General's Report (Agenda Item 6)

The FARM Committee received the report dated August 5, 2015, from the CFO entitled "Auditor General's Report Update", a copy of which report will be filed with these minutes.

The CFO advised that many of the items on the checklist have been completed with the exception of some items which will now be completed in Q2 2016. The current review being conducted by the City on consolidation of real estate services is driving a number of the City action items.

Action Item: Send a note to City Manager reminding them that Auditor General is coming back; and of our desire to get all points cleared up.

The CFO advised that the re-rostering process is continuing and it is very time consuming, but most of the action items will be completed by end of this year.

The CEO has scheduled a meeting with new City Manager – there will be a briefing on Build Toronto with a list of outstanding items of AG report. The CEO is to provide an update to the Committee on how the discussion went.

The CEO confirmed that Management is comfortable with the way that procurement and transaction documents are being retained and stored
